FIELD NOTES
 "a", "b", "c", and "d" - Found 5/8" iron bars on a survey by Jack Fitch, L.S. #335, on a plat dated February 18, 1997.
 "b" - Found 5/8" iron bar. I set a 3/4" x 30" iron pipe at recorded distance.
 "c" - Set 3/4" x 30" iron pipe at recorded distance. This point matches well with field evidence and Jack Fitch's 1987 survey.

DESCRIPTION
 A tract of land located in the SW 1/4 of Section 4, T17N, R1W of the 6th P.M. in Platte County, Nebraska, more particularly described as follows:
 Commencing at the north east of 8th/10th Subdivision as surveyed May 1, 1958, and assuming the old south right-of-way of U.S. Highway #81 to have a bearing of S 52°41'18" E, 524.18' E, 50.00 feet, thence S 00°45'18" E, 15.45 feet, to the point of beginning, thence S 52°47'45" E, 302.71 feet, thence S 10°28'18" E, 198.30 feet, thence S 42°28'43" E, 81.40 feet, thence N 72°08'18" W, 331.23 feet, thence N 00°45'18" W, 304.70 feet, to the point of beginning, said tract containing 1.54 acres, more or less.
