- Program was awarded a water sustainability fund. USGS and NCSD are working on it together focusing on recharge. Lateral recharge is being looked at, not just vertical recharge.
- Katie is working on the annual 5-year contracts with each NRD.
- Lewis and Clark project with Cedar Knox rural water-surface water intake is being silted in right now. The project is on the list to receive federal funds.

## B. Department of Natural Resources – Mike Thompson

- Update on DNR's move to Fallbrook in March.
- Registrations were reviewed
- Discussing the need for 2 types of replacement wells put into the database. Statutory and functional, which will differ by whether the original well was replaced or modified within the 180-day statutory time limit.
